

## Agreement

This agreement is concluded between the following parties: **Sport Agency OÜ** (TT-cup series tournament), registry code 16456558, address A. Puškini tn 19-98, Narva (hereinafter the **Organizer** of the Competition), represented by member of the board Aleksandr Smirnov

And

\_\_\_\_\_, year of birth \_\_\_\_\_, personal identification number \_\_\_\_\_ (hereinafter referred to as the **Player**), hereinafter referred to as a separate **Party** or together the **Parties**, entered into this Agreement (hereinafter the **Agreement**) in the following:

### 1. The organizer of the competition is obliged to:

- 1.1. to provide the **Player** with sports equipment and conditions for participating in competitions, such as a professional **ITTF**-certified table, sports flooring and a high-quality indoor climate in the hall.
- 1.2. provide the **Player** with the opportunity to register for **TT-Cup** competitions and confirm the **Player's** participation in the tournament in advance.
- 1.3. to ensure that the competition is conducted in accordance with the rules for the organization of the table tennis competition.
- 1.4. provide the **Player** with the necessary information about the competition, which is: the competition schedule, the game results of the competitions, conditions and procedures.
- 1.5. to provide accommodation or reimbursement of transport costs if the **Parties** have agreed on this in advance.
- 1.6. to pay prize money to the **Player** according to the tournament instructions. Prize money is paid at the beginning of each week.

### 2. The player is obliged to:

- 2.1 follow the norms of sports ethics, be polite to competitors, judges and spectators
- 2.2 know and follow the rules of table tennis, as well as the game schedule
- 2.3 be ready for the game and be in the hall 15 minutes before the start of the game according to the schedule
- 2.4 to bring two T-shirts of different colors for the competitions. Sportswear must be clean and tidy.
- 2.5 During competitive games, give your best to win the game. Intentionally losing individual points, sets or games is strictly prohibited.
- 2.6 to play in specialized table tennis sports shoes.
- 2.7 submit a health certificate in case he has health problems or disorders that may endanger the health of the **Player** as well as the **Players** present in the hall.
- 2.8 to leave the hall when his game is over, except in cases where this does not contradict clause 2.3 of this **Agreement**.
- 2.9 sign a paper agreement on the rules of participation in competitions.

### 3. The player is prohibited from:

- 3.1 to participate in fixed matches, organize fixed matches and bet on fixed matches if the **Player** has information about fixed matches.
- 3.2 to bet on all **TT-Cup** competition series games, including **TT-Cup** tournaments organized abroad
- 3.3 influence (in any way) the judges' decision
- 3.4 to damage or intentionally hit the sports equipment of the hall (table, table net, walls, benches, etc.). When equipment or other damage is caused, the **Player** is obliged to pay for the damage caused.
- 3.5 behave rudely towards other **Players**, the staff of the competition **Organizer** or spectators. Gesturing, shouting and commenting on the game must remain within the framework of sports ethics.
- 3.6 interfering with other games (in any way),
- 3.7 consumption of alcohol, narcotics, drugs or other prohibited medical substances (except in cases where the **Player** has been prescribed a medical substance by a doctor) during the tournament as well as outside the tournament.
- 3.8 entering the hall with a weapon or an animal
- 3.9 entering the hall in outdoor shoes
- 3.10 to be a spectator in the hall if this does not conflict with point 2.3
- 3.11 smart watches and smartphones may not be used in the hall

### 4. Violation of clauses of the contract:

- 4.1 If the **Player** violates clauses 3.1 - 3.3 of this **Agreement**, the **Organizer** has the right to disqualify the **Player** from all **TT-Cup** series tournaments. In addition, the **Organizer** of the Competition has the right to forward information to the Estonian Anti-Doping and Sports Ethics Foundation, the Estonian Table Tennis Association and the police for violation of clauses 3.1-3.3 of the contract.
- 4.2 In case of violation of point 3.4 of this **Agreement**, the **Organizer** of the Competition has the right to demand compensation for the damage caused by the **Player**.
- 4.3 In case of violation of clauses 3.5-3.10 of this **Agreement**, the **Organizer** of the Competition has the right to prohibit the **Player** from participating in tournaments. The duration of the ban from participation in the tournament is determined by the **Organizer** of the competition

4.4 In the case of detection of manipulation of the results of competitions, including suspicious bets, the content, structure and volume of which indicate the intention to illegally influence the results of sports competitions through a fixed match or an identified situation where the manipulation of the game may give a third party an illegal profit, the **Organizer** has the right to interrupt the continuation of the given match or cancel its results.

4.5 In case of violation of points 1.1 - 1.5 by the **Organizer** of the Competition, the **Player** has the right to interrupt his performance in the competitions without fines from the **Organizer** of the Competition.

### 5. Processing of player's personal data:

By signing the **Agreement**, the **Player** gives the Competition **Organizer** permission to process and store the **Player's** personal codes and the **Player's** bank details.

By signing the **Agreement**, the **Player** consents to the publication of competition protocols, the coverage of competition results, photos and videos of the tournament in social media, media and betting platforms (press, television, radio), the processing of competition results and the publication of rankings.
